

PREA ANNUAL REPORT – 2020 (PRISON RAPE ELIMINATION ACT)

OVERVIEW

In 2020, Pioneer Human Services (PHS) contracted for three community confinement programs across the State of Washington. These contracts were with the Federal Bureau of Prisons (FBOP).

The development and maintenance of an agency-level zero tolerance policy ensures that awareness and accountability exist within the agency and throughout its community confinement facilities.

PHS facilities work with the contracting agencies to increase awareness, training, accountability and focused program procedures to work towards sexual safety and a decrease in sexual misconduct.

There were no PREA allegations in 2020 calendar year.

FEDERAL RESIDENTIAL REENTRY CENTERS (FBOP)

PIONEER FELLOWSHIP HOUSE



The Pioneer Fellowship House Residential Reentry Center (PFH/RRC) is a 60-bed facility that houses both males and females located in Seattle, WA. PFH/RRC provides both in-house treatment as well as referrals within the community for substance abuse, job and life skills, educational opportunities and financial education.

There were no substantiated PREA investigations in 2020 thus a facility action plan is not warranted. However, any substantiated or unsubstantiated allegations would automatically go to the PHS PREA Review Committee.

SPOKANE RESIDENTIAL REENTRY CENTER (Sites 1 & 2)



The Spokane Residential Reentry Center (SRRC) Site 1 serves males who are in the custody of the Federal Bureau of Prisons, or under the supervision of the US Probation or the Pre-trial Services. The 38-bed facility houses males only, but supervises both males and females while on home confinement. Residents are required to be fully employed or enrolled in an education program, participate in recovery/counseling, complete in-house work details and meet all screening requirements for placement.

The Spokane Residential Reentry Center (SRRC) Site 2 serves males and females who are in the custody of the Federal Bureau of Prisons, or under the supervision of the US Probation or the Pre-trial Services. The 35-bed facility houses both males and females and supervises both while on home confinement. Residents are required to be fully employed or enrolled in an education program, participate in recovery/counseling, complete in-house work details and meet all screening requirements for placement.

There were no substantiated PREA investigations in 2020 thus a facility action plan is not warranted. However, any substantiated or unsubstantiated allegations would automatically go to the PHS PREA Review Committee.

TACOMA RESIDENTIAL REENTRY CENTER



The Tacoma Residential Reentry Center (TRRC) houses both males and females who are in the custody of the Federal Bureau of Prisons, or under the supervision of the US Probation or the Pre-trial Services. The facility houses a maximum population of 35 residents.

There were no substantiated PREA investigations in 2020 thus a facility action plan is not warranted. However, any substantiated or unsubstantiated allegations automatically go to the PHS PREA Review Committee.
