It is with great sadness that I write this letter to inform you that the Fawcett Clinic will be closing its doors after many years of serving the City of Tacoma and Pierce County communities. This is due to the direct impact that Covid 19 has had on our out-patient and residential programs services, as well as a decrease in sustainable revenue streams for the Fawcett Clinic.

For those of you currently actively involved in treatment services we will be working with you in determining the best transition plan for you either by; 1) Completing treatment or 2) Transferring your services to a place of your choice. To provide the best outcomes for these transitions we are working closely with those community partners, to honor where you are recommended for continued treatment, rather than starting all over at a new provider's location.

The closing date for The Fawcett Clinic will be April 30th 2021. We have started reviewing all currently enrolled clients and their involvement in treatment service, the following transitioning criteria is being implemented;

- 1. No treatment services since Feb 2021 or before will be closed as of March 26th
- 2. If you are currently active in treatment you will work with your clinician to develop a transfer plan or treatment completion plan that will have your chart closed as of April 15th, 2021.
- 3. April 15th is the last day for Groups at The Fawcett Clinic

Other Important Transition items:

- Your medical records will be continuing to maintain the privacy and security of your health care
 information according to State and Federal Law. In the future if you need copies of your medical
