To Whom It May Concern:

It is with great sadness that I write this letter to inform you that the Rainier Clinic will be closing its doors after many years of serving the Seattle community. This is due to a decrease in sustainable revenue streams for the Rainier Clinic.

For those of you currently actively involved in treatment services, we will be working with you in determining the best transition plan for you either by: 1) Completing treatment or 2) Transferring your services to a new treatment provider of your choice. To ensure the best outcomes for your care, we are transitioning over three months to close our door. The closing date for Rainier Clinic will be June 30, 2021.

Here is what you can expect over the next three months:

1. If you have not received treatment services since February 2021 or before, your treatment plan will be closed as of March 26.
2. If you are currently active in treatment, you will work with your clinician to develop a transfer plan or treatment completion plan and your chart at Rainier Clinic will be closed as of June 15, 2021.
3. If you currently are on medications prescribed by Dr. Slightam, you will need to reach out to your primary care provider to establish coverage for your ongoing medication. Dr. Slightam's last appointment for Rainier Clinic clients will be June 15, 2021.
4. The last day for groups at Rainier Clinic will be June 18.

Other important transition items:

- We will continue to maintain the privacy and security of your health care information according to state and federal law. If you need copies of your medical health record in the future, please call 206-768-1990.
- Attached is a list of resources to support you in your transition.
