### Apply for REDUCED-COST Glasses

Eyeglass applications accepted  
**Monday-Friday 9am -3pm**

New Eyes purchases new prescription eyeglasses for low-income individuals in the U.S. through an e-voucher program. A \$15 nonrefundable application fee is payable when each eyeglass application is submitted.

#### Eligibility Guidelines:

- Be in financial need - reside in a household with net monthly income below 250% of US Poverty Guidelines.
- Copy of current prescription from a recent eye exam (within the last 24 months)

#### Application Procedure:

- Bring unexpired eyeglass prescription to **Carnegie Resource Center**.
- Fill out E-voucher application.
- Select eyeglass frames.
- If approved, glasses will be delivered within 5-7 business days.

## MONDAY

- **Re-Entry Healthcare Navigation (UHC) 9:00am - 3:00pm**  
*Service not available Sept 22<sup>nd</sup> & 29<sup>th</sup>*  
Representative able to assist UHC members releasing or recently released from incarceration get connected to services, resolve issues or answer coverage questions.
- **DVS of Snohomish County 11:00am - 1:00pm (Sept 8<sup>th</sup> & 22<sup>nd</sup>)**  
Domestic Violence Services of Snohomish County will be available to answer questions about DVS & the wide ranges of services provided to survivors of abuse.
- **Employment Navigation (TRAC Associates.) 1:00pm - 4:00pm (Sept 15<sup>th</sup>)**  
Individualized employment services to support eligible individuals overcome barriers in obtaining and maintaining employment.
- **Coordinated Entry/Resource Navigation (SnoCo) 1:00pm - 4:00pm**  
Screening and assessment for individuals and families experiencing homelessness.  
*Eligibility criteria must be met to access service.*

## TUESDAY

- **Veterans - Homeless Patient Aligned Care Teams (HPACT) 9:00am - 11:30am**  
HPACT team consists of an MD and Social Worker that work with unhoused veterans who are VA healthcare eligible wanting to get connected with primary care at the VA.
- **SSVF Program (YWCA) 9:00am - 12:00pm**  
Supportive Services for Veteran Families (SSVF) Program promotes housing stability among very low-income Veteran families who reside in or are transitioning to permanent housing. Eligibility requirements must be met to qualify for services.
- **Veterans Affairs Supportive Housing (HUD-VASH) 9:00am - 12:00am**  
HUD-VASH provides permanent supportive housing for eligible homeless Veterans. To be eligible Veterans need to be homeless or chronically homeless and meet income requirements for their local Public Housing Authority (PHA). HUD-VASH is a collaborative program that pairs HUD's Housing Choice Voucher (HCV) rental assistance with VA case management and supportive services.
- **Medicare (Molina Healthcare) 9:30am - 12:00pm (Sept 2<sup>nd</sup> & 16<sup>th</sup>)**  
Molina Healthcare Medicare Advisor will be in attendance to provide \$0 cost benefits for individuals with dual eligibility (Medicaid and Medicare) or Medicare only. Advisor available to advise, educate, and support those with Medicare related questions.
- **Veterans - Coordinated Entry (SnoCo) 10:00am - 12:00pm**  
Screening and assessment for veterans experiencing homelessness. Support is provided to access resources and to develop action plans to address identified needs.
- **Veteran Assistance Program (SnoCo) 10:00am - 12:00pm**  
A representative will be available to meet with veterans seeking assistance. Learn more about federal VA benefits and programs, including eligibility criteria for Veterans' Assistance Funds.

- **Healthcare Navigation (Community Health Plan of WA) 10:00am - 2:00pm**

Representative available to assist individuals seeking healthcare coverage, answer inquiries regarding Medicaid coverage and resolve CHPW plan concerns.
- **Orca LIFT Cards (LCSNW) 10:00am-1:00pm (Sept 9<sup>th</sup> & 23<sup>rd</sup>)**  
Enrollment representatives available to issue Orca cards to qualified individuals.  
*\*Issuance of ORCA Lift cards are reserved for new and renewal clients only\**
- **Naloxone Giveaway (Evergreen Recovery Centers) 10:00am - 2:00pm (Sept 23<sup>rd</sup>)**  
Evergreen Recovery Centers HOST Program will be on-site to distribute 2 Nasal Naloxone Kits (aka Narcan) to each individual who attends.
- **Lifeline Program – Phones, Tablets & SIM Cards 10:30am - 2:30pm**  
Get free SIM cards (for GSM unlocked devices) and affordable phones and tablets. Phones require a one-time \$20 co-pay, and tablets require an \$80 co-pay. Availability is based on the representative's inventory. Lifeline representative will be on-site to confirm eligibility—please bring proof, such as a benefit award letter.
- **North Sound 211 (VOA) 12:00pm-1:30pm**  
Individuals can meet with a Community Resource Advocate from 211, who will assess their needs and match them with available services in their area.
- **Behavioral Health/Supportive Svcs. (Helping Hands Project Org.) 11:00am - 1:00pm**  
Agency offers support for individuals facing mental health challenges and/or substance abuse. Services include intensive case management, housing assistance BH counseling, and more. *Eligibility criteria must be met to access service.*
